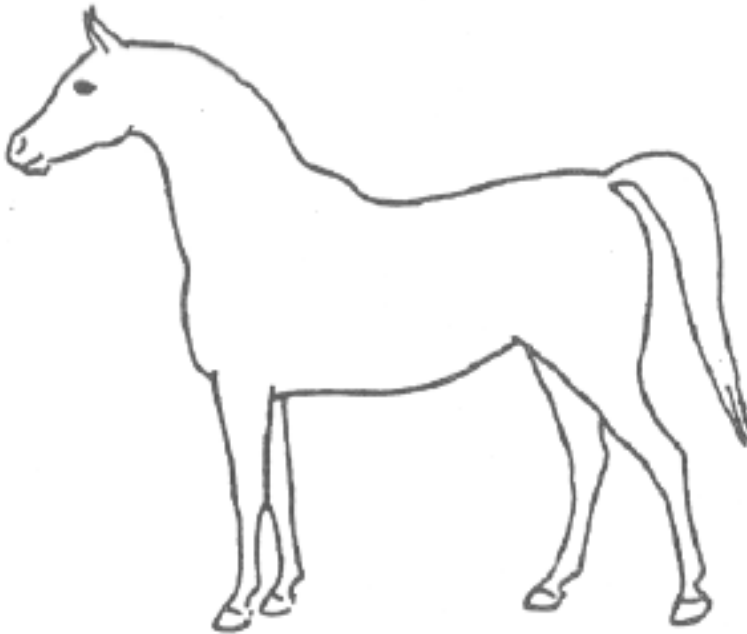

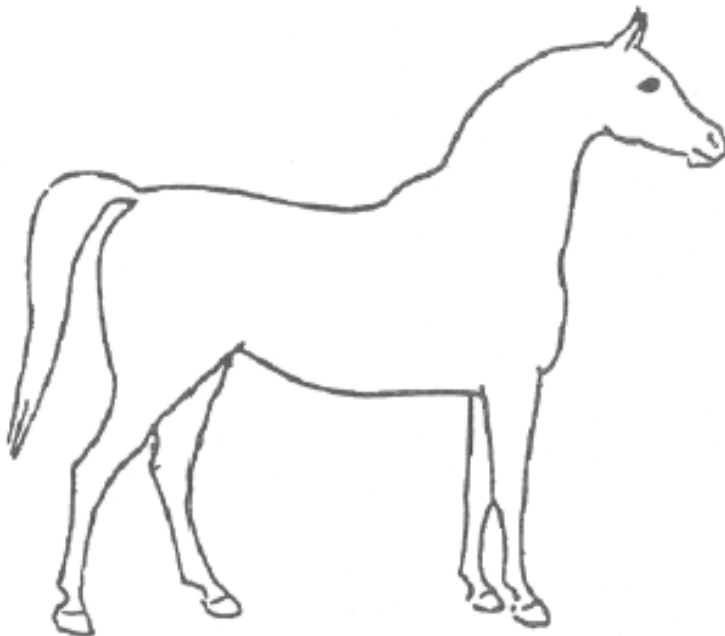

ADDITIONAL STALLION/ MARE REGISTRATION REQUIREMENTS

- All Colts require DNA typing for adult registration - refer to the APSB office for DNA kits and details.
- Applications for stallion registration are to be accompanied by an APSB Stallion Certificate Of Suitability (completed by a practicing veterinarian). Both Highland Pony males and females are required to be DNA tested as of the 2004 breeding season with the initial application for registration.
- Adult registration of filly's or colts to geldings require original certificate of registration be returned with application.
